**Student accident insurance, ambulance cover, and private property brought to school - Annual reminder**  
The Department does not provide personal accident insurance or ambulance cover for students. Parents/carers of students, who do not have student accident insurance/ambulance cover, are responsible for paying the cost of medical treatment for injured students, including the cost of ambulance attendance or transport as well as any other transport costs.

Parents/carers can purchase insurance policies from commercial insurers.

Private property brought to school by students, staff or visitors is not insured and the Department does not accept any responsibility for any loss or damage.

This can include mobile phones, calculators, toys, sporting equipment and cars parked on school premises. As the Department does not hold insurance for personal property brought to schools and has no capacity to pay for any loss or damage to such property, students are discouraged from bringing any unnecessary or particularly valuable items to school.

### **Camps, Sport and School Excursions Fund (CSEF) - Annual reminder**

Eligible families can access the CSEF to help families with the cost of camps, sporting activities, excursions and incursions, so that a family's financial circumstances are not a barrier to student participation. Eligibility details are available on the application form. Families who have a financially means-tested card (eg Health Care Card), or children in Out-Of-Home-Care arrangements. #### **Compass Consent Required through 'Course Confirmation/Payments'**

Please log into Compass and provide consent for

- Walks in the Community - Annual consent**

This provides MPS with consent for students to take walks in the community throughout the year. Families are still informed of the date, time and location of local walks, without requiring consent for each event.

- Acceptable Use of ICT and Digital Technologies - Annual reminder & consent**

Consent is required for students to use the school's digital devices, and agree to the acceptable use of equipment and programs at school.

- Publicity and Media Consent**

Annual consent for student's names and images to be used across a range of platform from the school.

## **FINANCIAL ASSISTANCE**

### **INFORMATION FOR FAMILIES**

Every Victorian child should have access to the world of learning opportunities that exist beyond the classroom. The Camps, Sports and Excursions Fund [helps](#) ensure that no student will miss out on the opportunity to join their classmates for important, educational and fun activities. It is part of making Victoria the Education State and the Government's commitment to breaking the link between a student's financial circumstances and their outcomes.

### **CAMPS, SPORTS and EXCURSIONS FUND (CSEF)**

School camps provide children with inspiring experiences in the great outdoors. Excursions encourage a deeper understanding of how the world works while sports teach teamwork, discipline and leadership. All are a part of a healthy curriculum.

CSEF is provided by the Victorian Government to assist eligible families to cover the costs of school excursions, camps and sporting activities.

If you hold a valid means-tested concession card or [support](#) an out of home care [student](#) you may be eligible for CSEF. A special consideration category also exists for asylum seeker and refugee families. The allowance is paid directly to the school to use towards expenses relating to camps, excursions or sporting activities for the benefit of your child.

The annual CSEF amount per student is \$400 for all school students.

### **HOW TO APPLY**

New applicants should contact the school office to obtain a CSEF application form or download from the website below.

If you applied for CSEF at your child's school last year, you do not need to complete an application form this year unless there has been a change in your family circumstances.

You only need to complete an application form if any of the following changes have occurred:

- **new student enrolments:** your child has started or changed schools this year.
- **changed family circumstances:** such as a change of custody, change of name, concession card number, or new siblings commencing this year.

Check with the school office if you are unsure.

## **Bushfire At-Risk Register Schools—School Procedure for the bushfire season.**

Monbulk Primary School listed on the Bushfire At-Risk Register (BARR) as we are at risk of bushfire attack. As such, there are special arrangements and requirements for the maintenance and operation of the school.

Fire Danger Ratings and warnings are used in Victoria to provide clear direction on the safest options for preserving life.

Monbulk Primary School will be closed when a Catastrophic Fire Danger has been declared by the Bureau of Meteorology for the **Central District**.

Monbulk Primary School may be closed when an Extreme Fire Danger has been declared by the Bureau of Meteorology for the Local Government Area (LGA) of the **Yarra Valley**.

We provide families with as much notice as possible of a closure by letter, SMS message and Compass notifications. Once confirmed, the decision to close will not change, regardless of improvements in the weather forecast. This is to avoid confusion and help your family plan alternative care arrangements for your child.

It is also important to note that:

- No staff will be on site on days where the school is closed due to a forecast Catastrophic or Extreme Fire Danger Days.
- Out-of-school-hours care will also be cancelled on these days.
- School camps and excursions will be cancelled if a Catastrophic Fire Danger Day is determined for the Bureau of Meteorology district in which the camp is located.

Families are encouraged to develop and enact their Bushfire Survival Plan regardless of school closure. On Catastrophic and Extreme days children should never be left at home or in the care of older children.

What can parents do?

- Make sure your family's Bushfire Survival Plan is up-to-date and includes alternative care arrangements in the event that our school is closed.
- Ensure we have your current contact details, including your mobile phone numbers. Keep in touch with us by reading our newsletters, by checking our website and by talking to your child's teacher or any other member of the teaching staff about our Emergency Management Plan.
- If you're planning a holiday or short stay in the bush or in a coastal area, you should check warnings in advance of travel and remain vigilant during your stay.
- If your child is old enough, talk to them about bushfires and your family's Bushfire Survival Plan.

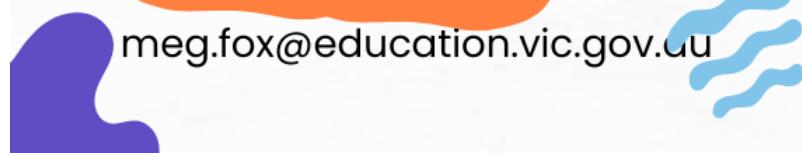

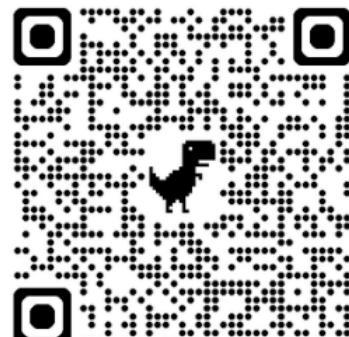

## FORM 2: NOTICE OF ELECTION AND CALL FOR NOMINATIONS

(Formerly **Schedule 4: Notice of Election and Call for Nomination**)

An election is to be conducted for members of the school council of Monbulk Primary School

Nomination forms may be obtained from the school and must be lodged by **4.00 pm on: 20th Feb 2026**

Following the closing of nominations a list of the nominations received will be posted at the school.

The terms of office, membership categories and number of positions in each membership category open for election are as follows:

MEMBERSHIP CATEGORY	TERM OF OFFICE	NUMBER OF POSITIONS
Parent member	From March 2026 To March 2028	5

If the number of nominations is less than the number of vacancies, there will be no need for an election. If an election is necessary all applicants will be notified and ballot will be sent out on 2nd March 2026 and an election day will be announced.

### **What is a school council and what does it do?**

All government schools in Victoria have a school council. They are legally constituted bodies that are given powers to set the broad direction of a school, in accordance with Ministerial Order 1280 Constitution of Government School Councils, and the Education and Training Reform Act 2006. In doing this, a school council may directly influence the quality of education for students.

### **Who is on the school council?**

For most primary school councils, there are several possible categories of membership:

**A mandated elected parent member category** – more than one-third of the total members must be from this category. Department employees can be parent members at their child's school providing that they are not engaged in work at the school.

**A mandated elected school employee member category** – members of this category make up no more than one-third of membership. The principal of the school is automatically one of these members.

**An optional community member category** – members are co-opted by a decision of the council because of their special skills, interests or experience.

Department employees are not eligible to be community members.

A small number of school councils have **nominee members**.

For all schools with a Year 7 and above cohort, there is an additional category of membership:

### **A mandated elected student member category, two positions**

Generally, the term of office for all members is two years. The term of office of half the members expires each year, creating vacancies for the annual school council elections.

### **Why is parent membership so important?**

Parents on school councils provide important viewpoints and have valuable skills and a range of experiences and knowledge that can help inform and shape the direction of the school.

Those parents who become active on a school council find their involvement satisfying and may also find that their children feel a greater sense of belonging.

### **Do I need special experience to be on school council?**

Each member brings their own valuable skills and knowledge to the role, however, in order to successfully perform their duties, councillors may need to gain some new skills and knowledge.

It is important to have an interest in your child's school and the desire to work in partnership with others to help shape the school's future.

### **Code of conduct for school councillors**

School councils in Victoria are public entities as defined by the *Public Administration Act 2004*.

School councillors must comply with the Code of Conduct for Directors of Victorian Public Entities issued by the Victorian Public Sector Commission.

The Code of Conduct is based on the Victorian public sector values and requires councillors to:

**act with honesty and integrity** – be truthful, open and clear about their motives and declare any real, potential or perceived conflict of interest and duty

**act in good faith in the best interests of the school** – work cooperatively with other councillors and the school community, be reasonable, and make all decisions with the best interests of students foremost in their minds

**act fairly and impartially** – consider all relevant facts of an issue before making a decision, seek to have a balanced view, never give special treatment to a person or group and never act from self-interest

**use information appropriately** – respect confidentiality and use information for the purpose for which it was made available

**exercise due care, diligence and skill** – accept responsibility for decisions and do what is best for the school

**use the position appropriately** – not use the position as a councillor to gain an advantage

**act in a financially responsible manner** – observe all the above principles when making financial decisions

**comply with relevant legislation and policies** – know what legislation and policies are relevant for which decisions and obey the law

**demonstrate leadership and stewardship** – set a good example, encourage a culture of accountability, manage risks effectively, exercise care and responsibility to keep the school strong and sustainable.

### **Indemnity for school council members**

School councillors are indemnified against any liability in respect of any loss or damage suffered by the council or any other person in respect of anything necessarily or reasonably done, or omitted to be done by the councillor in good faith in:

the exercise of a power or the performance of a function of a councillor, or

the reasonable belief that the act or omission was in the exercise of a power or the performance of a function of a council.

In other words, school councillors are not legally liable for any loss or damage suffered by council or others as a result of reasonable actions taken in good faith.

### **How can you become involved?**

By participating in, and voting in the school council elections, which are held in Term 1 each year. However, ballots are only held if more people nominate as candidates than there are positions vacant.

In view of this, you might consider:

standing for election as a member of the school council

encouraging another person to stand for election.

### **What do you need to do to stand for election?**

The principal will issue a Notice of Election and Call for nominations in Term 1 of each year. Council elections must be completed by 31 March, unless varied by the Minister for Education.

If you stand for election, you can arrange for someone to nominate you as a candidate or, you can nominate yourself in the parent member category. You can only be nominated by another member of the same electorate that you are eligible for (e.g. a member of the parent electorate may only nominate another parent of that electorate)

Department employees with a child enrolled at a school where they are not engaged in work, are eligible to nominate for parent membership at that school.

Return your completed nomination form to the principal within the time stated on the Notice of Election. You will receive a Nomination Form Receipt via post, email or by hand delivery.

Generally, if there are more nominations than vacancies a ballot will be conducted in the two weeks after the call for nominations has closed.

### **Remember**

Consider standing for election to school council.

Ask the principal for instructions if you are not sure what to do.

Be sure to vote if the election goes to ballot.

Contact the principal if you are unsure about what is required at any stage of the election process.
